Such a Service of Blessing shall include these essential elements: (a) a mutual exchange of promises of lifelong love and fidelity, or an affirmation of promises previously exchanged in a civil ceremony; (b) an invocation of the Triune God to be present in the strengthening and the fulfillment of the promises exchanged; and (c) a prayer of Blessing offered by the pastor (and, if appropriate, the congregation) and a pledge to support the couple in the fulfillment of their promises.
- 4. In preparation for the Service of Blessing, we encourage: (a) consultation between pastor and congregation council prior to the first occasion for a Service of Blessing to determine congregational policy for such services; (b) prayerful and intentional preparation by the couple with the pastor before the Service of Blessing; and (c) the demonstration of the fruit of the Spirit (Galatians 5:22-23) in the life of the couple;

AND BE IT FURTHER RESOLVED, that this Synod, meeting in Assembly, direct the Synod Council to submit a resolution to the ELCA Church Council to direct the

BE IT RESOLVED that the Northwest Washington Synod memorializes the ELCA Churchwide Assembly to make provision for a relationship of Full Communion to be granted to all rostered persons in good standing, who for reasons of conscience may find it necessary to leave the ELCA, and yet find no conflict with continued service in an ELCA congregation or setting, and, BE IT FURTHER RESOLVED that the Northwest Washington Synod memorializes the ELCA to keep on its rosters all persons in good standing, who desire to remain on the roster even if the congregation or setting chooses to leave the ELCA.

(ELCA Constitution S2.03 in its entirety); and 2. Luther's statements about the Scriptures being the lowly swaddling clothes holding the Christ to whom the angels point (paraphrase, Luther's Works, vol. 35, 236); and 3. sound principles of Biblical interpretation, such as e. using Scripture to interpret Scripture when it is unclear; and f. interpreting texts in their literary context; and g. interpreting texts in their historical context; and h. praying for the guidance of the Holy Spirit; and 4. the continuing presence of the Holy Spirit in using church doctrine, contemporary experience and scientific knowledge as tools for discerning God's will through the Holy Bible.
