REPORTS

Verbal Report from the Bishop

Bp. Shelley noted that she did not provide a written report for this meeting but referenced her lengthy written report provided with the Synod Assembly reports.

- She has been to a series of board meetings. Two that were noted were Pacific Lutheran University and Luther Seminary. Both schools are struggling because of fewer resources.
- Three pastors are considering going on temporary leave because of physical/emotional issues; she lifted this up because, in our current world situation, there are more things that cause people to not be as resilient, and certain people surrounding these pastors are not inclined to be kind and caring; this is a concern for the bishop.
- Don Maier, former bishop and the second bishop to serve our synod, has now been put on hospice care.

Request from Assistant to the Bishop, Andy

There is a need for a Synod Council representative on June 8th for a call meeting at Prince of Peace Lutheran, Shoreline. **Cindy and Dan** will check their schedules and confer about fulfilling this role.

UPDATES SINCE THE LAST MEETING

Diversity, Equity, Inclusion and Belonging (DEIB) Work with the Organizing for Mission Network (OFMN)

The Equity Team, established as part of this process, has begun one-on-one conversations; they have either completed or scheduled 50. On the team from Synod Council are: Kay, Cindy, Sam, Shane and the bishop, and Judy represents synod staff on the team. One goal is to build a larger listening team.

FOR DISCUSSION

Synod Assembly Preparation

The following topics were discussed:

- Role of Council Members
 - Synod Council members were encouraged to arrive at 10 am to check in and then to greet voting members as they arrived at the convention center.
- Bishop Election
 - Nick spoke to his role as ELCA churchwide representative overseeing the election of the bishop.
- Review of Resolutions/Memorials
 - It was noted that an additional memorial might possibly be brought to the floor.
 - o Susan was called upon to explain the difference between a memorial and a resolution.

- Some questions were raised pertaining to the resolution in support of the Evangelical Lutheran Church in European Russia (ELCER). The bishop responded clarifying the history of how our relationship with this church body emerged and became part of ELCA's Companion Synod Program. It was also noted that the Lutheran Church in Ukraine left the ELCER, and we have never, historically, been related to the churches in Ukraine.
- The bishop was part of a three-synod ELCA delegation that recently went to Serbia to meet with three synods of the ELCER as an effort to strengthen the relationship between us. It is hoped that a meeting bringing together youth from all these synods might be able to be convened in the country of Georgia in the near future.

Budget

- The large gap between Mission Support and the projected cost of the fiscal year (FY) 2026 budget (balanced by using reserve funds) was acknowledged. It is a visionary budget which is anticipating future giving, and is not intended to be a sustainable, repeated model for the future.
- Among the reasons for the budget increase were bringing synod staff up to guideline salaries (as mandated by last year's Assembly) and adding a line item to the budget for Emerging and Strategic Ministries.
- Since Synod Council (SC) forwarded the budget to the Assembly, SC members were encouraged to speak to it and be willing to be engaged in budget discussions.

Worship

Worship will be woven throughout the Assembly which is a different approach than has been taken in past assemblies.

Bishop's Report

 The bishop's report will also take a different approach than in the past. Each rostered minister on staff is sharing a Staff Weavings based on scripture and their specific ministry areas. There will be two on Friday and two on Saturday.

Considerations for Discerning Sale of Congregational Property

Beginning steps have been taken for creating a working document to be a guide for congregations in the synod thinking of selling some or all their property yet continuing to exist as a congregation.

Synod Organizational Chart and Acronym/Specialized Vocabulary List

The Evangelical Outreach (EO) Team has made a request to Synod Council to consider creating an organizational chart for the synod along with a glossary of specialized synod vocabulary and acronyms. Judy made a start on this with the glossary of acronyms she posted on Teams. Andy Arnold found another synod who had done a glossary, and there are other examples from other synods. Kay is interested in working on this but help from others would be welcome.

Update on Glendale Property

Our Director of Properties has reported that we are close to having a final financing document with the church buying the Glendale property. Synod Council will need to act quickly to approve or reject this agreement.
